May 1-2, 2020 Judging Meet

We will hold this Judging Meet at Larry Gerig's museum on County Road S. 600 E. The location is 1.4 miles east of the HWY 24 & HWY 114 junction. From I-69 take the HWY 24 Exit and go South West about 5½ miles to the HWY 114 Junction. Take a right and go west about 1.4 miles. Turn right on County Road S. 600 E. turn into the first driveway on your right. There are several nice hotels at the I-69 HWY 24 Exit.

Event is limited to 4 cars per class with a limit of 12 cars including concourse providing there a sufficient judges. Judges/Tabulators get \$10.00 off of the registration fee.

Registration opens 01/01/2020. NO JUDGING ENTRIES Postmarked after April 16 2020.

Friday afternoon 1:00 PM to 4:30 PM will be Operations Judging and staging of cars. A Judging School will begin when all of the cars are staged for judging. All cars will be locked in the museum overnight.

Registration is Friday May 1 from 1-5 P.M. and Saturday Staring at 7:30 A.M. Owners meeting at 8:00 – 8:15 judging will then commence. Lunch will for be served all participants.

Don't forget to mention that we will need Indiana Chapter Members to step up and volunteer to help make the 2020 convention a huge success.
